STIPULATION FOR DISMISSAL

Pursuant to Minnesota Rule of Civil Procedure 41.01(a), Plaintiffs Tanya Mae Wagner, Dale Allen Jones, DeAndre Jerome Barnes, Michael Lee Doering, and Robert Rosas Sr. and Defendant Minnesota Department of Corrections (DOC), by and through their respective undersigned counsel, stipulate to the following:

- 1. As of the date of this stipulation, Plaintiffs Barnes, Rosas, and Wagner are serving their criminal sentences in the community on conditional medical release.
- 2. As of the date of this stipulation, Plaintiffs Doering and Jones are serving their criminal sentences in the community on supervised release.
- 3. Plaintiffs Barnes, Rosas, and Wagner shall remain on conditional medical release until they reach their supervised release dates, at which time they will transition to traditional supervised release. The DOC shall not rescind Plaintiffs Barns, Rosas, or Wagner's conditional medical release under Minn. Stat. § 244.05, subd. 8(e). Upon a finding that Plaintiffs Barnes, Rosas, or

Wagner have violated their conditional medical release conditions, the DOC may seek to revoke their conditional medical release in accordance with Minn. Stat. § 244.05, subds. 3 & 8(f).

- 4. The DOC shall modify Plaintiffs Barns, Rosas, and Wagner's conditional medical release conditions, which currently include strict home confinement, to allow them to be employed outside their homes and to pursue education outside their homes with approval from their supervision agents.
- 5. All claims and causes of action stated in Plaintiffs' complaint against Defendant shall be dismissed.
- 6. All parties will bear their own costs, disbursements, and attorneys' fees.
- 7. The court may forthwith sign the proposed order of dismissal and enter judgment thereupon.
