

# LEGISLATIVE PRIORITIES

## Fines & Fees

Driving-related fines and fees can add up. If people can't afford to pay their fines quickly, they can lose their licenses, their jobs and even go to jail. Reforming Minnesota's system of escalating fines and excessive fees would allow people to keep their licenses and stay out of jail for low-level traffic violations. We support **HF 1060/SF 1375** and **HF 1061/SF 1736**.

## Forfeiture

Minnesota's forfeiture system is broken. Law enforcement across Minnesota are using seized items to fund their budgets. In 2018 alone, these agencies made more than \$8.2 million from cash and property obtained through civil forfeiture. The people most affected are those with the fewest resources to fight to get their property back. Combining civil forfeiture into the criminal court process will provide stronger due process protections. Reallocating proceeds will address the appearance of "policing for profit."

## Privacy

Law enforcement is required to seek warrants before conducting searches. Applying outdated laws to new technologies has created loopholes that compromise the personal privacy rights of Minnesotans.

**Drones:** Currently, law enforcement can use drones without getting a warrant. Police must get search warrants before using other methods of surveillance, and drones should not be an exception. We support **HF 3009/SF 3074**.

**Electronic Communication:** Under existing Minnesota law, after 180 days, law enforcement can access your emails and text messages – without a warrant – because those emails and texts are considered "abandoned." This loophole should be closed. We support **HF 3010/SF 3071**.

**Equality before the law.** We have the right to be treated equally regardless of nationality, race, gender, sexual orientation, religion, ethnicity, disability or socioeconomic status.
