#### Federal Judge Rules Against Demonstrators

After a strong effort by the ACLU-MN to protect the free speech rights of individuals wishing to demonstrate during the upcoming Republican National Convention in St. Paul, the court delivered a disappointing decision in July in the suit between the City of St. Paul and the Coalition to March on the RNC and Stop the War.

The lawsuit filed by the ACLU-MN initially challenged the City's refusal to grant a march permit for a coalition of national and local groups planning a massive anti-war march on the first day of the RNC, September 1st. In May, the evening before the hearing when the ACLU was going to ask the judge to force the city to issue a permit, the city finally denied the Coalition's permit application and instead granted an alternative permit.

The ACLU-MN believes that the City's alternative route and timeline does not meet constitutional requirements. First and foremost, the alternative permit guarantees that the marchers will be unable to deliver their message to the RNC delegates because they must be clear from the area before the delegates start arriving for the convention. In addition, the proposed alternative route lacks adequate capacity for a crowd in excess of 50,000 marchers, a concern verified by an independent traffic-engineering firm. The alternative route requires marchers to march back on themselves for the entire route, and requires them to turn at 90-degree angles at the narrowest points on the streets to be used. In addition, the route does not have the same profile as the proposed route from the State Capitol, down John Ireland Boulevard to Kellogg Avenue past the *Continued on page 4*

St. Paul, Minneapolis, and Bloomington are getting ready for an invasion of political activity greater than anything we have ever seen. During the last weekend of August, approximately 14,000 Republican delegates, 14,000 media representatives, and 100,000 protestors will come to the Twin Cities to express their views, write their stories and protest the war and current economic policies.

The ACLU of Minnesota has spent more than a year and a half and \$20,000 in protecting the free speech rights of both the delegates and of the protestors. In addition, nine firms have spent thousands of hours of time, researching and writing briefs that will allow everyone involved to pursue their first amendment rights.

In order to make this effort possible, the ACLU of Minnesota will hold a major fundraising dinner at the Minneapolis Club on Monday, August 18<sup>th</sup>. Dinner will be at 7:00 p.m. The main speaker will be Nadine Strossen. This is Nadine's 17<sup>th</sup> and last year as the president of the American Civil Liberties Union and the 18<sup>th</sup> is her birthday. Tickets are \$125 per person, \$85 of which is tax deductible. Sponsorship opportunities are available. More information about the event is available on page seven of this newsletter.

The next day, August 19<sup>th</sup>, Fredrikson and Byron law firm will host a Continuing Legal Education program for attorneys interested in representing protestors if they are arrested during the Convention in September 2008. We are also concerned about the potential for the mass arrests of protestors at demonstrations the weekend before Labor Day and during the first four days of September. Finally, as you can read about in other parts of the newsletter, we will have a booth at the State Fair for the first time in many years. Congratulations to board member Wally Hilke and Public Education Coordinator Jana Kooren for their long hard work to get the State Fair to admit the ACLU of Minnesota. #### Tarek ibn Zayad **Academy**

The ACLU-MN is investigating allegations that a Minnesota charter school, Tarek ibn Zayad Academy, is improperly promoting religion in violation of the Establishment Clause. Although charter schools are

incorporated as nonprofit organizations that are exempt from most state laws, they are considered public schools that receive state and federal funds and they must still follow U.S. and Minnesota Constitutional requirements. The allegations center on the school's relationship with a religious organization, the Muslim American Society of Minnesota, as well as practices at the school relating to prayer, religious activities and after-school religious instruction.

A Minnesota Department of Education investigation noted some practices that should be modified in orlegal—Continued on page 5

constitutionally sufficient. We suggested that the Court grant a permit for a march that incorporates the first half of the Coalition's route with a portion of the City's proposed route. Such a compromise would address the City's concerns while also providing the necessary capacity to hold the anticipated number of protesters.

However, the court granted the City's desired route and refused to order changes to the time and duration of the march.

The Coalition sought to carry out a safe, permitted march. They sought to do the right thing and deliver

der to comply with the law; however, the MDE investigation focused primarily on statutory provisions with little emphasis on the U.S. and Minnesota establishment clause provisions. Although we believe that the MDE has taken some important steps to address concerns that have been raised by the school's activities, the ACLU-MN has remaining concerns about the school's practices that were not addressed in the MDE findings. For that reason, we are continuing our investigation into this matter. In addition to our investigation of TiZA, we are also working to identify systemic issues that may be paving the way for constitutional violations in Minnesota charter schools.

#### **Watershed District**

The ACLU-MN filed an Amicus Curiae brief on behalf of Mr. James Stengrim, in support of his First Amendment rights. Mr. Stengrim was sued by the Middle-Snake-Tamarac Rivers Watershed District, a local government entity, for expressing an opinion critical of the District's flood control plans. Mr. Stengrim and other land owners opposing the flood control project filed suit against the District in 2002. At that time a settlement agreement was reached and one provision of it forbade the land owners from challenging the project again.

Consistent with the agreement, Mr. Stengrim has not filed a legal challenge since, but remains an outspoken critic of the District's plans. Further, he has filed several requests for District documents related to the project. In response, the District is now attempting to silence Mr. Stengrim by suing him for breach of the settlement agreement, arguing that his outspoken criticism and data requests constitute a new challenge to the project.

Under both the United States Constitution and Minnesota state law, Mr. Stengrim and all citizens have a right to freely express their opinions without fear of punishment or reprisal. The District acts in contravention of that right, seeking to intimidate its critics through lawsuits. Under Minnesota law, Mr.

Stengrim may seek the dismissal of any civil suit that seeks to silence lawful speech or action aimed at government action, but the lower courts have refused to apply that law.

The Minnesota Court of Appeals has now agreed to hear the case and the ACLU-MN is urging them to protect the First Amendment. Our inalienable rights to free speech may never be signed away by contract or quashed by lawsuit. Mr. Stengrim has upheld his end of the settlement agreement, but the District seeks to ignore the laws and silence their opponents. The ACLU opposes such unconstitutional tactics and will always work to defend all people's rights to speak freely without fear of punishment.

#### **Pledge Policy**

For well over sixty years, courts have recognized the First Amendment right of students to choose not to participate in the Pledge of Allegiance. As the Court in West Virginia State Board of Education v. Barnette put it in 1943, "[i]f there is any fixed star in our constitutional constellation, it is that no official, high or petty, can prescribe what shall be orthodox in politics, nationalism, religion, or other matters of opinion or force citizens to confess by word or act their faith therein." So when a small group of students at Dilworth-Glyndon-Felton Schools were disciplined when they exercised their right to remain seated during the Pledge of Allegiance, the ACLU-MN stepped in to remind the District that their actions were patently unconstitutional. Our letter informed the District of their obligation to follow the constitution and suggested that this incident represented a classic "teachable moment" where the school could help to instill the values of good citizenship by modeling respect for the U.S. Constitution and the rights and values that our flag represents.

The DGF School Board ultimately voted to do the right thing and repealed their policy requiring students to stand during the Pledge of Allegiance, but not before voting the proposed repeal down at its first meeting after the incident.
